## **QUESTION:** Why attend a Specialty Show?

## ANSWER: A Great Way to Meet Other Scottish Terrier Owners !!

This information comes from the American Kennel Club (AKC) website, AKC.org.

AKC Specialty shows provide exhibitors and owners with a unique opportunity. These events focus on your specific breed, so they are a great way to meet and learn from other knowledgeable and passionate Scottish Terrier owners.

You don't have to enter to join the fun, but if you've done some training and handling and want to compete with your dog, you should submit your entry form. Entries typically close two to three weeks prior to an event.

## **Both Exhibitors & Spectators Are Welcome!**

- $\Rightarrow$  Potential for a large Scottish Terrier entry!
- $\Rightarrow$  Judges with significant knowledge of your breed.
- $\Rightarrow$  No registration is required for spectators. Just show up!

#### **All-Breed Shows**

All-Breed shows are conformation events that are held for the more than 190 breeds and varieties of dogs recognized by the AKC to compete in, unless otherwise noted on the club's premium list. Also listed under All-Breed are the Group Shows, or shows limited to one of the seven AKC Groups: Sporting, Hound, Working, Terrier, Toy, Non-Sporting and Herding. Approximately 1,500 AKC All-Breed conformation point shows are held throughout the United States each year.

#### **Specialty Shows**

Specialty shows are events limited to a single breed, e.g. Bulldogs, or the varieties of one breed like Poodles, which include the three varieties: Toy, Miniature and Standard. Some specialty shows may be held in conjunction with an All-Breed event, while others are stand-alone events. There are about 2,000 independent national, regional and local specialty point shows held every year.

There is no better place to learn about your breed than at a Specialty Show, in particular the national specialty ("the National"), which is usually held annually by the breed's national parent club. It's where dedicated fans of the breed meet together year after year, sharing their knowledge and passion and bringing their best dogs to compete.

As with any dog show, the point of the conformation classes is determination of the best breeding stock to continue the breed - and this point is taken nowhere more seriously than at specialties and particular the National. A class win at the national can be a high point of a dog person's year, and a Best of Breed or Best in Sweepstakes is often a pinnacle achievement for a person with a long history in a breed.

Whether you're a prospective owner researching a breed, a new owner, or an experienced breeder, handler or judge, Specialty Shows are your best opportunity to spend time with others who share your love of the breed. Many provide educational seminars and may offer other events such as obedience, tracking, and agility, as well as breed-specific performance venues such as earthdog or field trials, herding tests and trials, lure coursing or draft test.

There are many specialties across the country every year. Take a look at upcoming national and regional breed specialties or search for national to local specialties, which are often held in conjunction with an All-Breed show at AKC Event Search and Results (<u>https://webapps.akc.org/event-search/#/search</u>).

#### MORE GOOD TO KNOW INFORMATION ON VESTIBULAR DISEASE

From Phyllis Stamper:

"I wanted to share a little more insight into Vestibular Disease. Just before we left for Utah the end of June, McBriar got it again - this time affecting the right side. At the end of July, you could still see a slight tilt to her head.

When I took McBriar to the veterinarian before we left, and mentioned I had been giving her Metronidazole for irritable bowel inflammation, she said Metronidazole toxicity can produce the same symptoms! That may be part of the etiology for McBriar. Now I give her a probiotic about every other day and that seems to prevent symptoms so far.

Once again, she is fully recovered and back to her sassy self!!"

Note: Phyllis later relayed that the vet put McBriar on Proviable-DC which is a multi-strain probiotic. She has used both the paste and capsule version.

#### STCC STATEMENT OF FINANCIAL POSITION

With the club now fully separate from rescue, our fiscal year end will be June 30th going forward (as defined in our bylaws). The bank balance at June 30 was \$4,912.53 (club \$3,727.77; trophy fund \$1,184.76). At August 20th, accounting for all deposits and expenses through the luncheon, the bank balance was \$4,768.28 (club \$3,572.37; trophy fund \$1,195.91).

During the August 2017 luncheon to June 30, 2018 period (doing my best to allocate any prior activity to this fiscal year, our Profit & Loss statement for club showed income of 3,133.00. Expenses totaled 5,048.95. It should be noted that this expense amount included one time costs of 656.00 to obtain our articles of incorporation, to change our formal name with the Illinois Secretary of State, and to apply for our 501(c)(7) tax exempt status.

Other items of note:

2018/19 Dues - 41 members (or 82% renewed their memberships - both individual or household); 9 members chose not to renew (3 individual and 3 household memberships). The club added 10 members during the 2017/18 time frame.

Communication Committee expenses included \$300.89 to publish the Plaid Piper; \$380.67 for web costs.

The June 2018 Specialty costs to-date total \$722.07 (we are awaiting a small deposit from GLATA).

Fundraising activities brought in \$296

Trophy donations were \$915.00; Trophy costs were expected to total \$853.85. Actual costs were \$\$743.85 (\$110.00 in cash awards not needed during the show itself).

#### \*\*\*\*\*\*

We have already received \$75.00 in donations for the 2019 trophy fund. It is time to set budgets for this year, including trophies, and work is already underway towards our 2019 Specialty and our potential hosting of the 2021 National Rotating.

September 1, 2018

Dear Club Secretary:

Please read this letter aloud at your next club meeting. It is important that every member of your club hear and understand the importance of this call for action. If members of your club are not present; please include this letter with the sending out of your meeting minutes.

Once again the legislative year has flown by and the legislature is in recess until the fall veto session. Regardless of this being an election year, we expect some dog related legislation to come back in the veto session and HSUS to be very forceful in their approach. We have asked our lobbyist, Shaw Decremer to come back in the fall to help us defend your ownership rights.

The Federation is asking every club to pay their renewal dues and to add a few extra dollars in the check to the Federation.

The long and short of it is that the Federation only has sustainable funds for one more year of fighting anti dog breeder and anti dog ownership legislation for you. HSUS and a few other Animal Rights groups are very well funded and they do not want you to own or breed a dog. They are doing their best to systematically faze people like you and I out of our passion.

We depend on a strong lobbyist to do much of the work behind the scenes to promote the IFDCO opinion. This work is not free. It cost the Federation \$2,000 @ month while the legislature is in session. Our lobbyist, Shaw Decremer, has continued to help us open doors that were never available to us in the past. Every member club of the Federation can be proud of the work he does every day for us.

Our funding comes from clubs like yours paying their membership dues, clubs donating \$1 @ entry at their competitions, and outright donations [some from bake sales, catalog sales, 50/50 raffles], and individual membership dues. At the end of the 2019 veto session, we will be without funds to continue. Please help us fight for your rights in Illinois to own and enjoy your dogs.

The mailing address for the Federation is: IFDCO – PO BOX 13043 – Springfield, IL 62791-3043.

This year every position on the Board of Directors is up for reelection and some directors have voiced their desire to step down. The Federation is looking for new members to serve. So, if any of your club members have a passion for the continuance of purebred dog ownership in Illinois we would love for them to step forward. Please have them contact the Federation and we will get them to the nominating committee.

We also have Federation lapel pins at \$5 each. If you have club members who want to join the Federation as individuals, they can get a free lapel pin by joining. Be sure to wear your pins at every dog related event to show your support. Wearing the pin starts conversations.

Lastly, we did have a successful Spring Session with a piece of legislation which we initiated. It was passed and the Governor signed it into law [Public Act 100-0870]. It will, among other provisions, provide essential data on exactly where and why animals are coming into Illinois shelters and animal control facilities, and what happens to them once they are there. This includes determining how many animals are coming from outside the state and country.

Legislation that restricts animal owners and breeders is commonly proposed due to misplaced concerns about shelter population or animal health issues. This new law will provide a full and accurate picture of exactly why animals are entering shelters, where they are coming from, and their ultimate outcome. This will provide factual data and greater clarity about issues so that real problems can be addressed and the most appropriate policies to benefit animals can be put in place.

We hope to see you with the 4-days of competition at the Prairieland Classic Cluster of dog shows in Springfield. They are in the Exposition Building on the Illinois State Fairgrounds. Bring a friend. Take the entire weekend off, bring your dog and enter the shows – and don't forget to send in your dues for 2018-2019.

The Scottish Terrier Club of Chicago

The Scottish Terrier Club of Chicago was founded in 1930 by T.E. Weible and Mrs. M.F. Hills. On September 17, 1979, we were formally incorporated as a Not For Profit in the State of Illinois.

Our club is the 2nd oldest Scottish Terrier club in the nation. (California being the oldest club.) It is interesting to note that in 1959 there were still only eleven regional clubs. However, today, STCC is proud to be one of twenty Scottish Terrier regional clubs recognized by the Scottish Terrier Club of America.

STCC held its first Specialty show in November, 1930. Today, our Specialty shows are held annually the third Saturday of June at the Lake County Fairgrounds in Grayslake, IL.

Across the years our club has changed leadership and direction, as has every regional club. The allure of the Scottish Terrier has decreased, and nationally there is a strong conversation as to how to rebuild the breed, and our clubs. At our height we had 80 members. Although our membership declined, our current initiative is to expand our clubs footprint, and we are reaching out full force to add new members and, thus new energy and ideas. Today we boast 57 members and counting.

Most of our tenured members have served this club in a leadership capacity - at least once. And, there is a strong knowledge base across our club, focused on our mission. Breeders, exhibitors, and those with companion Scotties have come together with determination to improve the lives and futures of our Scotties.

In recent years, successes have been made for our breed. A test is available for Cushings Syndrome through Dr. Zimmerman and UTenn. Studies at Purdue University have increased our knowledge of bladder cancer. A home collection kit, made possible by Dr. Breen, allows owners to send in urine samples for diagnosis.

If this is the first (or 100th) time reading *The Plaid Piper*, you may have a strong, personal interest in our breed you would like to share. If not already, please consider joining as a member of STCC. Thank you.
